

1 SHEEHAN: She already testified?

2 BATES: My name is Priscilla Bates B-A-T-E-S. I live at 323
3 Paradise Road. That's on Lookout Mountain in the Paradise Hills Section. I
4 have lived there for 38 years. That's irrelevant and I would like to explain why.
5 My husband died of cancer 3 years ago. He had lived there 35 years and there
6 is nothing in those studies that have showed or are studying even now the
7 effects of long term radiation on humans. And in his 35 years he was a veteran
8 of World War II in excellent health, never smoked, drank an occasional beer. He
9 was on several Boards including our Lookout Mountain Water Board. And he
10 was also foreman of the Federal Jury in Denver, the Grand Jury and he did that
11 for two years. He was loving his retirement. Unfortunately our home is in direct
12 line of site with the towers on Mount Morrison and obviously were for the 35
13 years that he lived there. His favorite thing to do at night was to listen to his
14 stereo, sit and read his newspaper and that, the chair that he sat in was in direct
15 line of site with Mount Morrison. His cancer was in his throat on the same side
16 as the direct line with Mount Morrison. We have only single pane windows so
17 he was radiated then for approximately the 35 years and this is what I feel is so
18 significant because we have no studies and can't very well immediately come up
19 with studies showing the effects of long term radiation on humans. There is one
20 other point I would like to make and that is our dogs are dying in inordinate
21 numbers. Now there are no studies on our animals either but many of our dogs
22 are dying. Quite a few of them of Non-Hodgkins lymphoma and we have no
23 studies showing why this is happening either. So I think it's certainly something

1 to be to consider. Myself I can't understand how you as Commissioners can put
2 the interest of a private company ahead of the welfare and health of your
3 constituents. This is my big concern and I hope you'll act wisely. Thank you for
4 listening.

21 heard most of the arguments regarding the Lake Cedar Rezoning proposals
22 over and over and over. Commissioners and citizens alike I'm sure are weary of
23 year after year of hearings. Yet nowhere have we heard any real reason why
