21 heard most of the arguments regarding the Lake Cedar Rezoning proposals
22 over and over and over. Commissioners and citizens alike I'm sure are weary of
23 year after year of hearings. Yet nowhere have we heard any real reason why

1 Jefferson County Commissioners should be expected to worry over such
2 matters as the signal to Boulder, the most accessible and read cheapest
3 broadcast location. The quality of the signal or the alleged lack thereof are
4 indeed whether there is any HDTV broadcasting at all. These are Lake Cedar's
5 problems and solving them is not included in the job description for our
6 Commissioners. Their responsibility is to represent the citizens who elected
